Be well, dear church, and stand steadfast in the promise of God's love and grace as you take that promise with you into the world.

First Immanuel Lutheran Church Annual Meeting January 29, 2023

Call to order: Lauren Kim called the meeting to order at 1:03 PM.

Opening prayer: Pr. Melinda led us in our opening prayer.

Adoption of agenda: Motion to adopt the agenda was passed.

Quorum count: There were 37 voting members in attendance. Quorum passed.

President's remarks: Lauren talked about how crazy of a year 2022 had been with continuing to adapt to the needs of the church during/post-COVID times. She also noted the impact of losing Rose Haven as a tenant and the hard work by the newly created tenant task force to fill the vacancy.

Special recognition: Special thanks to Chia Stockwell and Chris Weiss. Chia has faithfully led the virtual worship space by running the Zoom for hybrid church services. Chris has helped with the sound system at FILC, including resolving a sound issue with the choir, with the Zoom service from the sanctuary, and setting up a YouTube channel for recorded church services.

Report of Nominating Committee: Thanks to Kent Fredrickson, Brian Martin, and Melissa Lathen-Bennett for their time on Council. Kent and Brian ended their second three-year terms. Melissa needed to step down after her first year. Tyrell Servo and Lynn Akerman were submitted to replace the two open three-year terms. Martha Driessnack was submitted to take over the remaining two years of Melissa's term. Jim Wick and Chia Stockwell have each agreed to serve a second three-year term on Council. Jim Dunn has agreed to serve a second three-year term on Endowment Committee

Elections: Council nominations for four three-year positions: Lynn Akerman (1st term), Tyrell Servo (1st term), Jim Wick (2nd term), Chia Stockwell (2nd term); one two-year position (with option to re-up for second three-year term): Martha Driessnack. Motion to approve all Council nominations as a slate was passed. Nominations were taken from the floor for nominating committee. Chris Koonce, Ryan Traetow, Pat Andeen, and Julie Young accepted nominations. Two Council members to serve on Nominating Committee to be determined later. Motion to approve Nominating Committee was passed. Motion approved for Jim Dunn to serve second three-year term on Endowment Committee. James Bash and Chia Stockwell volunteered and were approved to attend Synod Assembly. James Bash was elected to serve as Congregation President.

Treasurer's report: Kent shared comparison of end of 2021 vs. end of 2022. Insurance for building and contents has increased about 4% each year. Steeple repair loan is down to \$22k remaining (from \$75k initial loan balance) and will be paid off in just under 2 years. Envelope offerings finished about \$15k under budget of what we planned/hoped to receive in 2022. We were a little optimistic last year thinking we'd have more attendance back in church but COVID has gone on longer than expected. People who pledge do tend to meet their pledges, but non-pledges don't always meet where we would expect/hope. Special gifts were received at Christmas and Easter, but we were still facing a \$60k+ deficit at the end of 2022. Year-end giving in response to year-end appeal brought the actual deficit down to \$19,188 which will be taken from reserve fund (leaving just over \$100k in the reserve fund). 2022 was an unusual year in that we did not have a tenant in lower Sodergren for the majority of the year. New tenants did move in and started paying rent in October. Endowment funds lost over \$69k over the year. Compensation and

benefits are a major part of the budget. Synod recommends a COLA each year. For 2022, FILC met Synod recommendation of 4% COLA. For 2023, Synod recommended 8.7%. FILC is not financially able to meet this COLA this year but will increase salaries mid-year if finances change and allow us to do so. Security services have also become a major expense over the last few years. Motion to approve Treasurer's report subject to audit passed.

2023 ministry proposal and recommendations: As noted in Treasurer's report, FILC had been overly optimistic in non-pledge giving for 2022, so the budget for 2023 is more conservative and aligned with what we actually received in 2022. Rental income budget increasing now based on new tenants and lease terms. We're starting the year with a proposed deficit of around \$40k. Synod benevolence will remain at \$12.2k. Cost for pastors' health insurance has decreased some due to Pr. Aaron going on Medicare. Auto expenses are increasing a bit to \$1.5k, hoping pastors will be able to start doing more home visits and things like that again in 2023. Prior years were somewhere between \$1k-\$1.5k and only since COVID had it dropped significantly. Reconstituted Finance Committee will be meeting to address ongoing financial issues. Committee will report to Council monthly. Members can also request copies of reports at any point during the year. FILC is not giving the recommended 8.7% COLA. In lieu of COLA, there is a new payroll tax for Paid Leave Oregon effective January 2023, funded through payroll deductions. Rather than withholding from employees' paychecks, FILC will cover the payroll tax and not deduct from paychecks. COLA would have increased budget by \$19k this year vs. \$1k for covering new payroll tax. There is no written policy for how big the reserve fund should be but Kent's guideline is not below \$100k, as this would keep the church going for two years. Motion to accept budget as proposed was approved.

Committee reports: Full reports are available online/within the annual report. James highlighted all of the hard work Jim Wick does around the church to maintain the property. Kent acknowledged Leslie Wong as financial secretary and Bobbi Varnes as teller for counting. He also noted Richard Wong has helped with tracking, and Debbie Rehn is a QuickBooks whiz. Finance Committee noted disappointment with not being able to meet COLA but that FILC does honor designated gifts, if any members would like to make designated gifts to help provide some kind of COLA or bonus. On behalf of Congregational Life Committee, it was noted that new cards (created by Rachel Dietz) have been ordered as part of the card care project and are also available to any members who would like some.

Acknowledgment and thanks: Thanks was given to the pastors, Debbie, Ralph, and Karl. Thanks also to all of our partner parking lots that allow FILC members to use them on Sundays.

Closing prayer: Pr. Aaron led the congregation in the Lord's Prayer.

Adjournment: Lauren Kim adjourned meeting at 2:11 PM.

REPORT OF THE PASTORS, 2023

Normally we begin our annual reports by reflecting on some of the significant events or accomplishments of the past year. This year we want to begin with expressing our appreciation and thankfulness for you. We served as your pastors for $22^1/2$ years, and we are tremendously grateful for the generous, kind and openhearted spirit of this congregation. The past year has been challenging in so many ways, especially with working to return to something like normal after Covid, Pr. Aaron's surgery, and finally preparing for both of us to retire on December 31, 2023. Congregational leaders and members have been tremendously supportive. We have been encouraged by the way congregational leaders stepped up to meet the tasks and challenges at hand. We were touched by the kindness and concern shown by all of those who provided meals and sent get well cards during Pr. Aaron's recovery. We are so grateful for the expressions of love and care we have received over recent months. Thank you!

Looking back over the past year, here are some of the important events, accomplishments and themes.

WORSHIP AND MUSIC

We have been thankful to see **in-person participation** in Sunday worship gradually getting stronger over the course of the year. The year really ended on a high note with the Children's Christmas Program, the Choir Cantata, and beautiful, festive services on Christmas Eve, Julotta, and New Year's Eve Day. We're also thankful for the leadership of Chris Weiss and Richard Wong, who helped improve the sound quality of our **hybrid services** and develop a strong presence on our YouTube channel. Pr. Aaron enjoyed leading the Lenten midweek services (with meditations inspired by a resource from Kate Bowler, "God Blesses the Lives We Actually Have") and was especially grateful for members of choir who led the singing of Holden Evening Prayer. Easter Sunday was a joy, complete with the Easter breakfast in Fellowship Hall and the children's Easter Egg Hunt on the lawn. It was a special joy to celebrate confirmation for 6 of our youth—Augie, Hugo and Pearl Matthias, Katy and Macy Drexler, and Luke VanDeGrift.

When the middle of the year was disrupted with Pr. Aaron's surgery and recuperation, Pr. Melinda held things together. We are both grateful for the help of colleagues who filled in when we were both away. We are very thankful that First Immanuel has such an **amazing team of worship leaders**. We give thanks for Ralph and Sue Nelson and Karl Jurisons, and for our devoted choir members and handbell choir members, for the leadership they give to music. We are grateful to be able to work with a creative and hardworking Worship and Music Committee, eloquent Assisting Ministers, and faithful volunteers who serve as lectors and ushers and prepare Holy Communion.

PROPERTY AND FINANCES

Property and church finances continue to offer some of our biggest challenges. After Rose Haven shelter moved out of the Sodergren Hall lower level last year, we were glad to welcome new tenants, Independence Network and Havurah Shalom. Unfortunately, none of our congregational leaders understood Multnomah County requirements for refiling for tax-exempt status. We truly appreciate the efforts of Marja Selmann and Jim Dunn, who are helping congregational leaders navigate this.

We have both been involved in a variety of other **property and finance related efforts** this year. Since we have been unable to fill the role of Outdoor Maintenance Sexton in the way we did in the past, a lot of the morning clean-up of the property has fallen to us pastors. Pr. Melinda helped out with the spring property clean-up day.

Pastor Melinda provided primary leadership in working with the Stewardship Committee to prepare the fall pledge program, "Following Christ—We Give Anew." We appreciated Bishop Laurie Larson Caesar's contribution to the effort, preaching in worship for Stewardship Sunday. We give thanks for the generosity of First Immanuel members who made pledges for 2024 and who made donations to help reduce the 2023 budget deficit. Pastor Aaron worked with the Endowment Committee to award endowment grants of \$13,775.

LEADERSHIP, ADMINISTRATION AND COMMUNICATION

As we've begun to make our way back to planning large, in-person congregational events, we've found that communication has been an ever-present concern. Regular contact and a reliable source of information are very important. Pastor Melinda oversaw the weekly e-news and website updates, and Pastor Aaron composed a weekly digital devotion. We continued to share preparation of weekly pastors' messages for the e-news, and are thankful for Council members who wrote for the e-news through Pr. Aaron's surgery and recuperation. We continued to post sermon texts and devotions on the FILC website. Administration is important for keeping a congregation running efficiently. Both pastors engaged in countless emails and phone calls supporting the work of Executive Committee, Council, and other groups. We truly appreciate the many able volunteers and our wonderful office manager, Debbie Rehn.

Pastor Melinda and Anna Wilde took the primary role in developing the April 29 **FILC Congregational Retreat**. 21 members attended, and we appreciate the contributions of everyone who contributed to the task of discerning the shape of our congregation's ministry for the future. The group identified a need for congregational self-care and re-engagement with members, focusing on internal work in order to build a foundation to reach out post-pandemic.

CHRISTIAN EDUCATION FOR ADULTS

Pastor Melinda led the Forum through several book studies while also managing a hybrid format for the group. In the winter and spring, Pastor Melinda led discussion of *The Book of Joy by His Holiness the Dalai Lama and Archbishop Desmond Tutu*. Next, we studied *Civic Life and Faith*, using a resource from the ELCA. Participants in the study were able to contribute to the development of ELCA social teaching. In the fall we discussed *The Liturgy of the Ordinary: Sacred Practices in Everyday Life*, by Tish Harrison Warren. In the winter, we began a study of **How to Know a Person: The Art of Seeing Others Deeply and Being Deeply Seen**, by David Brooks. The Forum continues to be a rich place for in-depth learning and thoughtful conversation.

CHILDREN AND YOUTH

Pastor Aaron enjoyed **Confirmation** classes for the 2022-23 program year, with 8 youth from First Immanuel and 5 youth from Zion Lutheran participating with their parents twice each month. We finished our exploration of the message of the Bible using Dan Erlander's *Manna and Mercy*. This fall a new class has begun for the 2023-24 program year, using Luther's Small Catechism and the Gospel of John as resources for exploring the essentials of Christian faith. Pastor Aaron is grateful for Pr. Joan Beck, who is leading the second half of the program beginning in January.

In the winter and spring, Pastor Aaron led **Sunday School classes** for elementary kids, developing a curriculum based on stories from the beginning of the book of Genesis. We appreciate the congregational leaders who have stepped up to reshape Sunday School during Pr. Aaron's absence. One of the highlights of the year was the **Children's Christmas Program**, "Macy's Magical Christmas Program," with 22 children and youth participating. Pastor Aaron wrote the script to include special guests St. Nicholas, Ebenezer Scrooge and the Sugar Plum Fairy. It was a whimsical and fun way to tell the traditional Christmas story.

SUPPORTING COMMUNITY AND CONNECTION

Pastor Melinda worked with the Congregational Life Committee, which was active in **nurturing community and creating connections** between members. She coordinated the book group and participated in the Zoom baking days, which proved to be a wonderful way of bringing people together for fellowship. The committee was glad to sponsor events like the Easter Breakfast, Rally Day and the Advent Workshop, which were all well-attended. It was a joy to have time together for fellowship. The committee has continued to sponsor "care cards" sent to members. As we work at building up our faith community together in the aftermath of the pandemic, this group has been creative and energetic in sponsoring coffee time, meals and gatherings.

OUTREACH

We were excited to welcome **new members:** Anke Brandstater in March, and Marilyn Ball, Amy Harrison, Jane Sproul and Roy Scott and their daughter Allison in October. Pastor Melinda served as a pastoral liaison to Lift Urban Portland and its nutrition programs, which FILC supported with successful spring and fall **food drives** this year. We were glad to see FILC members support our longtime relationship with **Gallagher Plaza** low-income apartments with generous Giving Tree donations that made possible a \$15 Fred Meyer gift card for each resident at Christmas. We also are thankful for FILC members who are supporting outreach at Emmons Place, delivering groceries to residents from Lift Urban Portland. Both pastors participated in the **blood drives** this year and attended the **"Classical Up Close"** concert in April. It is a joy to welcome our neighbors to events in our space.

PASTORAL AND SPIRITUAL CARE

As pastors it is our great privilege to accompany members through the significant events of life and offer spiritual support. This year we rejoiced at the baptism of **Zachary Dietz** and celebrated with Rachel and Dan (and big brother Nolan). We also grieved the death of our member and friend, **Lynn Akerman**, and commended her into God's care. Pastor Melinda was thankful for the opportunity to support Mike and his family through a difficult time. Pastor Melinda also led the memorial service for Pastor John Trom, father of FILC member Jennifer Trom. We were able to make a number of pastoral visits this year to share Holy Communion, and we kept in touch by phone and Zoom with those who live alone or face struggles. Pastor Melinda updated the **Prayer Chain** with needs and concerns regularly, and Suzanne Nelson oversees the email Prayer Chain. All of these connections sustain faith and community in this challenging season.

WIDER CHURCH

We appreciate opportunities to be part of the wider church's life. Pastor Aaron served as chair of the Reference and Counsel Committee for the Oregon Synod Assembly this year. We both attended Synod Assembly online. Pastor Melinda serves as chair for the Oregon Synod Byberg Preaching Conference planning team. She also serves as dean for the Rose Cluster of the Oregon Synod.

TRANSITIONING TO NEW LEADERSHIP

During the past few months we've been working to make the transition to new leadership as smooth as possible. There has been a lot of knowledge to pass on, lists to update, responsibilities to share, and much more. We appreciate the diligence of First Immanuel's staff, council members and other leaders who have been tremendous partners, both in dealing with the immediate tasks at hand and looking ahead to prepare for the interim period. We're thankful that the Oregon Synod has found an interim pastor to lead you through the period of reflection and discernment ahead. We so value the joys of Christian community we've shared with you, and we believe in the future of Christ's work through First Immanuel.

Preparing to leave this community where we've shared 22½ years of ministry is bittersweet. We are excited about what the future may hold for us, but we're also sad to be leaving the friendships and the sense of belonging in community that have been such a gift. We appreciate the Synod's wisdom about needing to fully remove ourselves from First Immanuel in order to make room for discernment during the interim period and partnership with a new pastor after that. We will miss you and continue to pray for you, trusting that members will step up to the challenges of this transition time.

CLOSING THOUGHTS AND THANKS

We are truly and deeply thankful for the call to serve with you as your pastors. We have experienced First Immanuel as a lively, creative and grace-filled community. We value **our congregational leaders and staff.** They are both extremely competent and a joy to work with. We appreciate Skipper Bessette, Karl Jurisons, Ralph Nelson, Debbie Rehn, and Vicenzo Vargo.

Finally, we give thanks for you, the people of First Immanuel, for your joyful spirit and your commitment to Christ's work. We have worked hard together to find our way together through an exceptionally challenging time. Our relationships with each other and the faith we share give stability and peace in a tumultuous and anxious time. We are stronger, more patient and more compassionate because of the

support and encouragement we give to each other. As a community, we are a visible sign of God's love and care, the living presence of Christ in Northwest Portland. With our words and actions, we extend Christ's forgiving and healing work to our neighbors. We rejoice to have shared this community with you, worshiping God and serving our neighbors in Christ's name.

EDUCATION COMMITTEE REPORT—2023

Through the past year, as First Immanuel returned to in-person and hybrid education activities, we were happy to see participation growing.

Sunday School—Adult Forum

Through the winter and spring (the second half of the 2022-23 program year) the Adult Forum, led by Pastor Melinda, was held in hybrid format, beginning with a study of *The Book of Joy: Lasting Happiness in a Changing World*, by His Holiness the Dalai Lama and Archbishop Desmond Tutu. This was followed by a study of *Civic Life and Faith*, a resource from the ELCA. Participants in the study were able to contribute to the development of ELCA social teaching. In the fall Forum participants discussed Tish Harrison Warren's book, *The Liturgy of the Ordinary: Sacred Practices in Everyday Life*. Finally, in the winter, Pr. Melinda began a study of *How to Know a Person: The Art of Seeing Others Deeply and Being Deeply Seen*, by David Brooks.

Thank you to Pastor Melinda for providing growth opportunities for the mind, the heart, and the spirit.

Sunday School—Children's Ministry

Pastor Aaron began the year with a series for Sunday School exploring stories from the early chapters of the book of Genesis. Ralph Nelson led music for the kids. Attendance was somewhat sporadic, but the kids who participated had a wonderful time together. During the summer, Martha Driessnack led a thorough clean-up and organizing of the Sunday School rooms—thank you, Martha! OUTREACH COMMITTEE INITIATIVES FOR 2022

Collaboration with Lift UP:

- We continued to collect food during the year. This year we had increased emphasis to support needs during Spring Break and the Fall Nut Butter Drive (collecting 67 jars at last count, exceeding our goal of 50 jars).
- First Immanuel members have been delivering food boxes to Emmons Place Apartments once
 each month since April. Emmons Place is across the street on 18th Avenue and provides supportive
 housing to low-income seniors. Thanks to our core group of volunteers: James Bash, Anke
 Brandstater, Martha Driessnack, Lauren Kim, and Amy Harrison (who is coordinating the volunteer
 schedule). We were able to obtain a grant to purchase two wagons to help transport the food into
 the building.

Red Cross Blood Drive: Two successful events were held this year on May 7 and Dec. 8 (21 donors, 19 usable units collected).

PROPERTY COMMITTEE REPORT—2023

January 2023 began with a frozen furnace drain pipe. Waste water from the furnace exited the wall, froze, plugged the pipe and created an expanding pool of water moving toward Fellowship Hall. We thawed out the pipe and insulated it.

The biggest project this year was another flood in the lower level of Sodergren Hall. A drain at the south entrance to the lower level had plugged with debris after heavy rains, allowing rain water to enter the lower level and damage the walls. Debbie Rehn moved swiftly to get help. The drain was cleared and a contractor dried out the area. Then the walls were repaired and the baseboards replaced. Since flooding is frequently a problem which over the years has resulted in major costs, the property committee created a checklist of items to be done each Fall to avoid further expense.

A big thanks to everyone who helped in the Easter Cleanup this year. After weeding was completed, flowers planted and bark dust applied, the grounds looked great. In December, volunteers decorated the Christmas trees and the sanctuary in preparation for holiday activities.

This year, a light bulb needed to be replaced 22 feet above the choir loft and organ. The socket that held the bulb was loose, so instead of being able to unscrew the light bulb, the socket just turned. Heavy lift equipment would have gone through the floor, our ladders were too short, and scaffolding would have cost \$6,000. Finally, we built a platform four feet off the floor and placed a 16-foot ladder on top of the platform. What a job to change a light bulb!

- Easter cleanup & Christmas decorating (Bobbi, Kent, Lilli, Craig, Steve, Dan, Marilyn, Jim, James, Tyrell, Skipper, Pastors Aaron & Melinda)

- respond to maintenance emergencies



Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.


Receive our prayer, O God.
